A Brief History of NYALGRO and the Part I Played in It – In My Own Words – By James M. Tammaro, MLS



In December of 1980 the Town of Amherst was awarded a National Historic Publications and Records Commission (NHPRC) Grant to establish a local government archives. That grant was the catalyst for Amherst officials to establish a town-wide records management program.

In view of the above, in January of 1981 while serving as one of the Amherst Deputy Town Clerks I was also appointed the town's first Records Management Officer (RMO) and charged with initiating and then administering the town's records management program.

At the time, the Town of Amherst was the only town in New York State which had a formal records management program.

Then, in August of 1987 New York State adopted the Local Government Records Law. Among other things, the new Law required each local government to appoint a RMO to oversee the management of records in each local government. Interestingly enough Amherst was the only town in New York State where a local government had already appointed a RMO prior to enactment of the State Legislation. As a result, there was a special clause in the Law in Section 57.19 which applied only to Amherst which allowed already appointed RMOs to continue to serve as the RMO. This meant that, as Amherst Deputy Town Clerk, I was the RMO while in all other towns the new law required the town clerk serve as the RMO.

In any event, since the brand new Local Government Records Law instantaneously created the RMO position in every local government in the State, a few of the current RMOs or their appointees realized there was a need to form a new organization for RMOs and their appointees to network together and obtain educational opportunities at an annual conference. That new association would become the New York Association of Local Government Records Officers (NYALGRO). Therefore, in 1987 I was contacted by Robert Arnold who oversaw the Albany County and City Records Management Program and asked to serve as a founding member of the NYALGRO Board of Directors.

In those early years, our goal was to develop NYALGRO into a professional association which could offer guidance and networking possibilities for the improved management of local government records across New York State. I believe, over the years NYALGRO has continued to be a great source of assistance for newly appointed RMOs as well as other more experienced individuals charged with the awesome responsibility of improving the management of records and information in New York's local governments. The annual conferences were designed to be held in varying geographical areas in New York State to make it easier for RMOS and other records custodians to attend the NYALGRO Conferences on a regular basis.

I continued to serve on the NYALGRO Board until of July 1990 when I was appointed as the first New York State Archives Regional Advisory Officer serving Western New York. My appointment to the New York State Archives necessitated my resignation from the NYALGRO Board of Directors. However, as a member of the New York State Archives, I continued to make presentations at NYALGRO Conferences and represent the New York State Archives at the conferences. I was always a strong supporter of the association and promoted it strongly with the local officials I worked with while working for the New York State Archives.

In October of 2011 I had the opportunity to retire from the New York State Archives. Since I was no longer an employee of the State Archives I was free to establish a stronger relationship once again with NYALGRO. In view of this, in June of 2012 under the NYALGRO Presidency of Donna Mumbulo I was appointed as an ex-officio member of the NYALGRO Board on which I currently serve. My role with NYALGRO will be diminishing in the near future as I'm planning on resigning from the Board at the end of June of this year.

However, I will always cherish my memories of having served as a founding member of the New York Association of Local Government Records Officers.

- The New York State Archives is now accepting Local Government Records Management Improvement Applications for the 2020-2021 grant cycle. The application deadline is March 13, 2020. If you plan on applying here are some tips to follow:
- Make sure you have an eGrants username and password. If you're not sure contact the Grants Administration Unit at archgrants@nysed.gov
- Read the Grant Application Guide available at http://nnnv.archives.nysed.gov/common/archives/files/lgrmif_rfp_2020-2021.pdf
- Think about what your major records management problems are and how you may be best able to solve them.
- Talk to your Regional Advisory Officer (RAO) http://www.archives.nysed.gov/directories/rao
- If you need vendor quotes, contact vendors early in the grant writing process.
- Reread the grant application guide.
- Make sure you hit the submit button in eGrants before 5:00 p.m. on March 13, 2020.
