NYALGRO After School Business Meeting June 11, 2014

- 1. **Motion to approve January 10, 2014 meeting minutes**: Gina read the meeting minutes and a motion to accept them was made by Carol D. and 2nd by Rosemary S. and all accepted.

- b. Checking account has \$14,099.71 Savings has \$11,236.74 and the CD at M&T Bank has \$6708.64 totaling \$32,045.09 c. We have tried for years to save money by not using USPS and only use electronic means, but for a variety of reasons (wrong emails, firewalls, changes in roles) this is not working to ensure our members receive the school information in time to attend.
- d. A motion to approve this report was made by Pete S. and 2nd by Jim T. and all approved.
- 3. **NY State Archives Report**: None at this time.
- 4. **Bylaws:** The Vice President will run in elections opposite of when the President, Secretary, and Treasurer runs. ***Get wording from Donna M.
- a. The 2014-2015 terms: The President, VP for Events, Secretary and Treasurer. In December 2014 Carol D. term is finished, Desiree's old seat is finished with the term of office, Pete and Michele's (was Dan Karin's) seat terms are finished. We have two vacancies to fill. Desiree plans to move-up into Donna M. President's position the end of December 2014. Do we want to fill the other two board seats vacated?
- Rosemary S. will finish Kathy W. Treasurer position, due to Kathy's pending retirement.

This is a good thing. Gina made a motion to invite these five people at NYALGRO expense and 2nd by Carol D. to the September 2014 NYALGRO board retreat to plan the school due to their strong desire to be a future board member.
